3           EXAMINER CATANACH: Okay, at this time I'll call  
4 Case 13,738, which is the Application of Devon Energy  
5 Production Company, L.P., for compulsory pooling, Eddy  
6 County, New Mexico. Call for appearances.

7           MR. BRUCE: Mr. Examiner, Jim Bruce of Santa Fe,  
8 representing the Applicant. I just have a brief statement.

9           EXAMINER CATANACH: Okay, let the record show  
10 there are no additional appearances in this case.

11          MR. BRUCE: Mr. Examiner, this case was heard by  
12 Mr. Ezeanyim. I don't even remember the date, but it was  
13 heard some time ago. The only -- It was heard on July 6th,  
14 I think.

15          The only three people noticed -- notified of the  
16 hearing, were the Carlsbad Municipal School District and  
17 the Federal Deposit Insurance Corporation. They were given  
18 written notice. Subsequent to the Application being filed,  
19 both of those parties leased to Devon Energy. There was  
20 one additional person who could not be located, a Mr. H.L.  
21 Boyd.

22          And as I previously informed you, I was trying to  
23 get a notice published in the newspaper, and it took me  
24 about three or four attempts for the Carlsbad newspaper to  
25 respond, and so I kept continuing the case until I finally

1 got an affidavit of publication.

2 And so submitted as Exhibit 2 is the affidavit of  
3 publication against Mr. Boyd, and I would ask that this  
4 matter be taken under advisement.

5 EXAMINER CATANACH: Okay, Exhibit Number 2 will  
6 be admitted in this case.

7 And there being nothing further, Case 13,738 will  
8 be taken under advisement.

9 Thank you, Mr. Bruce.
