Dear Mrs and Mr. Kellogg:

This letter backs up our earlier emails and telephone discussions, letting you both know about our drilling venture. We are assuming that Mrs Kellogg does not want to sell her undivided interest and as such she has the option to participate in our drilling venture.

Based upon our title examination and subject to a possible Quiet Title Court judicial review, Mrs Kellogg may own an undivided .0011 to .015625 decimal interest in the captioned SW/4, being a .00055 to .0078125 of the W/2, 320-acre tract required by the New Mexico Oil Conservation Division to drill a Fruitland Coal test gas well. If Mrs Kellogg is found to own an undivided interest she has a number of options to consider regarding Fruitland Coal test wells, which are: Participate, or go non-consent.

Participation will cost Mrs Kellogg as much as \$3,437.50 net per well drilled. Or, she can elect to go non-consent and be subject to a 200% non-consent penalty, which is what the New Mexico Oil Conservation Division has accessed in other similar Force Pool Proceedings. As mentioned, Mr. Jerry Walmsley has initiated a Quiet Title Law Suit. He claims to own all the Margaret Jones Hasselman undivided interest.

If Mrs Kellogg wants to participate please sign the attached signature page to the enclosed Authority For Participate and include a check in the amount of \$3,437.50. We will also send her an Operating Agreement that will govern our working relationship for Mrs Kellogg's signature, assuming the well is capable of producing natural gas. Please consider hiring a New Mexico attorney to represent Mrs Kellogg's possible ownership. The Force Pool Hearing will be held in Santa Fe on June 22, 2006 and the Quiet Title Court Case will be heard in Farmington, New Mexico later this year. You, or your attorney may want to contact our attorney, Mr. Jim Bruce 505-982-2043 who is very familiar with the facts of this case. It would be best if you addressed your questions to Jim and/or I via email: JamesBruc@aol.com. As discussed, please be advised that Margaret Hasselman Jones did not make a Will and there was no Probate of her Estate. Without exception all the other Margaret Hasselman Jones heirs that we have contacted have elected to sell, many have already received their checks.

Your attention to this matter is appreciated.
