STATEMENT OF THE CASE

APPLICANT

Applicant seeks an order pooling all mineral interests from the base of the Queen formation to the base of the Morrow formation underlying the following described acreage in Section 32, Township 18 South, Range 31 East, NMPM, and in the following manner: The NW $\frac{1}{4}$ to form a standard 320-acre gas spacing and proration unit for any and all formations and/or pools developed on 320-acre spacing within that vertical extent, including the Undesignated North Shugart-Atoka Gas Pool and Undesignated North Shugart-Morrow Gas Pool; and the NE $\frac{1}{4}$ to form a standard 160-acre gas spacing and proration unit for any and all formations and/or pools developed on 160-acre spacing within that vertical extent. The units are to be dedicated to applicant's Porter House 32 State Com. Well No. 1, located at an orthodox location in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 32. Also to be considered will be designation of Chi Operating, Inc. as operator of the well. AT THIS TIME, APPLICANT SEEKS TO POOL ONLY THE RECORD TITLE OWNER OF A STATE OIL AND GAS LEASE.
