Dear Mr. Marchbanks:

As per our telephone conversations several weeks ago, this office is still assuming that you are the new owner of the above-referenced well. This office has yet to receive any official correspondence from you in regards to plugging and abandoning of this well. The following information on the enclosed forms will be required by this office within the next two weeks:

- 1) Sundry Notice - Form C-103, stating Spud date, size, depth, and cementing of surface casing, date T.D. was reached and size, depth and cementing of production string.
- 2) Sundry Notice - Form C-103, stating:  
Proposed plugging procedure and date plugging operation to be commenced.
- 3) Completion Report Form C-105:  
Fill in all appropriate spaces were applicable.

The information that this office has obtained from the numerous contractors that worked on this well is as follows:

- 1) 13 3/8 CSQ to 315' with 330 sx - circulated
- 2) 8 5/8" casing to 2020', cement circulated  
(640 sx).
- 3) Total depth: 7601'

- 4) 4 1/2" casing at 7510', cemented with 330 sx, estimated TOC at 5900'.


This office will require the following plugging program on this well:

- 1) Shoot and pull approximately 5900' of 4 1/2" casing.
- 2) 35 sx cement plug at approx. 5900'.
- 3) 25 sx cement plug at 4436' (top Abo formation).
- 4) 25 sx cement plug at 4128' (top Tubb formation).
- 5) 35 sx cement plug at 2924' (top Yeso formation).
- 6) 35 sx cement plug at 2020' - in and out of the surface casing shoe.
- 7) 10 sx plug at the surface.
- 8) 4" x 4' Dry Hole Marker stating the well name, T.D. and location

Should this information not be received in this office within the next two weeks, this matter will be set for the next examiner hearing for a forced plugging case. At this time the \$10,000 plugging bond will be forfeited to the State of New Mexico and this Division will plug and abandon this well as outlined above.

Your immediate attention in this matter would be greatly appreciated.

Knights Bridge Petroleum Corporation, Inc., Debtor, ("Knight's Bridge") filed a Chapter 11 petition in bankruptcy on May 1, 1987. The undersigned has been appointed trustee.

My duties as Trustee can be generally described as acting in the best interests of the creditors and the bankruptcy estate.

Initial efforts have been directed toward preserving the assets of the corporation. Field operations have been secured. My accountants are organizing and reviewing the financial records of Knight's Bridge to enable me to administer this business efficiently.

All of the personnel working to preserve the estate and conduct its affairs are experienced oil and gas "hands" who are well versed in the needs of this enterprise.

Obviously, we are very busy and I regret that I have not been able to speak with each of you personally. An organized business approach to operations and administration of this company is essential, especially since operations were interrupted by the State Receivership. This requires the most efficient use of the time of all my team and that, I believe you will agree, is in your best interest.

Once the preliminary evaluations of all properties are completed, with the cooperation of a number of former Knight's Bridge employees, I will prepare a report, probably in about three weeks and will send that information to you.
