**NOTICE OF CONTINUANCE OF SURFACE WASTE  
MANAGEMENT RULES HEARING  
AND OF PUBLIC OUTREACH MEETING**

The hearing before the Oil Conservation Commission concerning the Surface Waste Management Rules (proposed Rules 51, 52 and 53) scheduled for Thursday, March 23, 2006 will be postponed until April 20, 2006. The deadline for filing written comments and pre-hearing statements will also be postponed from March 16 to April 13.

The Oil Conservation Division will hold an Outreach Meeting on Friday, March 17 at 9:00 A.M. in Porter Hall at 1220 South Saint Francis Drive. The purpose of the Outreach Meeting will be for the Division's Environmental Bureau to explain its proposals, as incorporated in the draft rules published on February 27, 2006, and the reasons for those proposals. Stakeholder input will be accepted following the Division's presentation and response to questions, as time permits. The Division does not, however, contemplate further major revisions of its proposals prior to the April 20 formal hearing.

The hearing before the Commission on proposed Rule 50, currently scheduled for April 20, 2006, will also be postponed to a date to be announced later.
