**STATEMENT OF THE CASE**

**APPLICANT**

JTD Resources, LLC seeks an order pooling all mineral interests from the surface to the base of the Morrow formation underlying the E/2 of Section 23, Township 21 South, Range 32 East, NMPM, to form a standard 320-acre gas spacing and proration unit for any and all formations or pools developed on 320-acre spacing within that vertical extent, including the Undesignated Hat Mesa-Morrow Gas Pool. The unit is to be dedicated to the Papa Joe "23" Fed. Well No. 1, to be drilled at an orthodox location in the NE/4NE/4 of Section 23. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well.
