CHESAPEAKE'S MOTION TO VACATE AND RESCHEDULE COMMISSION HEARING

Chesapeake Operating, Inc. ("Chesapeake") hereby moves the New Mexico Oil Conservation Commission to vacate the hearing of these matter currently set commence at 1: 00 pm on Tuesday, October 3, 2006 and to reschedule these matter to a new date, and as grounds therefore, states that it has been surprised by Samson's et al untimely filing on September 26, 2006 of some 30 additional exhibits (identified as some 15 replacement exhibits and another 15 new exhibits) that Samson's intends to use at the October 3, 2006 hearing. See Exhibit A attached.

These cases were being heard by the Commission on August 10, 2006 when it was determined that the Commission would have insufficient time to hearing all the testimony within the scheduled time period. By agreement, these cases were continued to October 3, 2006 to commence at 1:00 with October 4th also being reserved for hearing these cases.

Samson waited 46 days and then one week before the hearing, and without prior discussions with counsel for Chesapeake, filed these additional exhibits.

In an effort to avoid this request, counsel for Chesapeake, after receiving these additional exhibits at 3:30 pm on September 26, 2006, Federal Expressed them to Chesapeake in Oklahoma City. Counsel for Chesapeake has been advised that both Mr. David Godsey and Mr. Rodney Johnson, its two primary witnesses in these cases, are unavailable to review these "surprise exhibits" and will not be able to do so until this weekend thus leaving insufficient time to review and be prepare to respond.

Chesapeake have been unduly surprised by these new Samson's exhibits.

This should be a hearing upon the merits based upon each parties best efforts to present good technical cases. It should not be a hearing by ambush.

Accordingly, Chesapeake moves at the Commission vacate this hearing and rescheduled these cases and in doing so enter a scheduling order to establishing

deadline for submittal of exhibits and witnesses and setting forth a schedule for to presentations of witnesses, exhibits including direct and cross-examinations.
