STATEMENT OF CASE

<u>APPLICANT</u>

Applicant seeks an order creating a new pool in the Second Bone Spring formation comprised of the W/2 of Section 11, Township 22 South, Range 26 East, and for the promulgation of special pool rules establishing 320-acre spacing and proration units with the option for a second well and designated well locations, including 660[' setback requirements. Applicant also seeks an exception fro the gas oil ratio limitation under Division Rule 506 A that would permit wells drilled within the proration unit within the pool to produce up to a GOR limitation of three thousand cubic feet of gas for each barrel of oil produced, along with a commensurate increase in the depth bracket allowable under Division Rule 505. In addition, Applicant seeks the temporary suspension of drilling permits within the boundaries of the proposed pool and the undesignated portions thereof for wells to be drilled at locations that are inconsistent with the well setback requirements proposed for the pool. Applicant is the operator of the Mesa-Grande 11 Well No. 2 (API No. 30-015-3720) completed in the Second Bone Spring formation of a location 2661' FSL and 660' FWL (Unit L) of Section 11. The subject lands and well are located approximately ½ mile southwest of Carlsbad, New Mexico.

OPPOSITION

Marbob Energy Corporation requests that the order that results from this hearing be limited to the W/2 of Section 11 and that there be no prohibition against development of offsetting acreage in the Bone Spring formation.
