WHEREUPON, the following proceedings were had at 1 9:09 a.m.: 2 CHAIRMAN FESMIRE: The next order of business 3 before the Commission today is combined Cases Number 13,492 4 and 13,493. 5 13,492 is the de novo Application of Samson 6 Resources Company, Kaiser-Francis Oil Company, and 7 Mewbourne Oil Company for cancellation of two drilling 8 permits and approval of a drilling permit in Lea County, 9 New Mexico. 10 Case Number 13,493, the de novo Application of 11 Chesapeake Permian, L.P., for compulsory pooling in Lea 12 13 County, New Mexico. Is there attorneys present in those cases? 14 15 MR. HALL: Mr. Chairman, Scott Hall appearing on behalf of Kaiser-Francis Oil Company. 16 17 MR. BRUCE: Mr. Examiner, Jim Bruce representing Mewbourne Oil Company. 18 Okav. 19 CHAIRMAN FESMIRE: Mr. Hall --MR. BROOKS: Mr. Chairman, David Brooks 20 21 representing the New Mexico Oil Conservation Commission --22 Oh, I'm sorry, you're calling -- you're not calling -- I 23 thought maybe I'd missed --24 CHAIRMAN FESMIRE: No. 25 MR. BROOKS: -- entering my appearance. You're

on the Samson. 1 2 (Laughter) MR. BROOKS: No, I'm not appearing in that. 3 CHAIRMAN FESMIRE: I accidentally read it, that 4 case, but we'll come back to it. 5 Right now we're on Cause Numbers 13,492 and 6 7 13,493. Mr. Hall, the Chairman has received -- read your 8 motion to allow additional evidence, as well as Samson's 9 10 response to that motion. At this time the Chair is going to deny that motion and continue with the proceedings 11 12 today. At this time I'll ask Counsel Bada to bring the 13 14 Commission up to speed on where we are with this case 15 procedurally. Counsel Bada? 16 17 MS. BADA: I've drafted the order based on the Commission's discussion at the January hearing, and I 18 believe all the Commissioners have had a chance to review 19 20 it. Hopefully it reflects what the Commission decided, 21 that there would be a 640-acre spacing unit. 22 CHAIRMAN FESMIRE: Commissioner Bailey, have you reviewed the drafted order as Counsel drafted it? 23 24 COMMISSIONER BAILEY: I've reviewed a draft, but I didn't see a final after all of the Commissioners had put 25
