



Devon Energy Production Company, L.P. has filed an application with the New Mexico Oil Conservation Division seeking an order approving an unorthodox gas well location in the South Los Pinos Fruitland Sand-Pictured Cliffs Gas Pool for its Northeast Blanco Unit Well No. 233, located 1400 feet FNL and 1 foot FWL (Unit E) of Section 23, Township 31 North, Range 7 West, NMPM. The NW¼ of Section 23 will be dedicated to the well. 
