





Devon Energy Production Company, L.P. has filed an application with the New Mexico Oil Conservation Division seeking an order approving an unorthodox gas well location in the South Los Pinos Fruitland Sand-Pictured Cliffs Gas Pool for the (drilled and completed) Northeast Blanco Unit Well No. 233, located 1400 feet FNL and 1 foot FWL (Unit E) of Section 23, Township 31 North, Range 7 West, NMPM. The NW¼ of Section 23 will be dedicated to the well. This matter is scheduled for hearing at 8:15 a.m. on Thursday, January 18, 2007, at the Division's offices at 1220 South St. Francis Drive, Santa Fe, New Mexico 87505. As a working interest owner in the NE¼ of Section 22, which the well encroaches upon, you have the right to enter an appearance and participate in the case. Failure to appear will preclude you from contesting this matter at a later date. Enclosed with this letter are a summary of interest ownership in the well unit and the offsetting unit, and a plat of the well's bottom hole location.

You are required to notify (in writing) the Division, and the undersigned, by Thursday, January 11, 2007 if you intend to participate at the hearing.


