Per letter dated March 27, 2007, Burlington Resources indicated that the well listed below was capable of producing unitized substances in paying quantities from the Mesaverde formation. 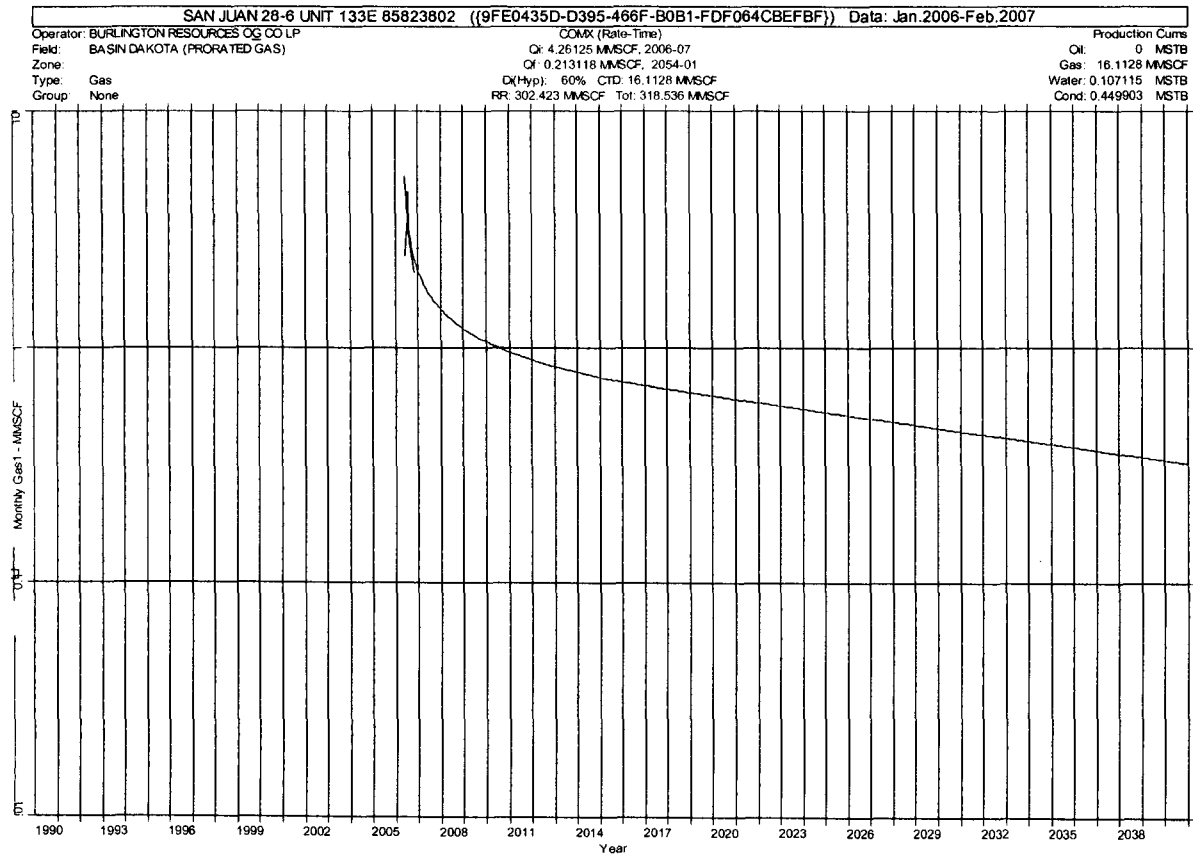
