
Dear Mr. Catanach:



NOTICE

To: Joel S. Johnson and Peggy La Plant, co-trustees of La Plant Johnson Family Trust u/t/a 4/12/94, and Coille Limited Partnership, their successors and assigns: Nadel and Gussman Permian, L.L.C. has filed an application with the Oil Conservation Division (Case No. 13878) seeking an order pooling all

mineral interests from the surface to the base of the Morrow formation underlying the N/2 of Section 22, Township 22 South, Range 28 East, NMPM, Eddy County, New Mexico, to form a standard 320-acre gas spacing and production unit for all formations or pools developed on 320-acre spacing, including the Dublin Ranch-Morrow Gas Pool. The unit is to be dedicated to the Big Chief Fee Well No. 10, to be drilled at an orthodox location in the NW/4NW/4 of Section 22. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well. The application is scheduled to be heard at 8:15 a.m. on Thursday, March 29, 2007 at the Division's offices at 1220 South St. Francis Drive, Santa Fe, New Mexico 87505. As an interest owner in the well unit, you have the right to enter an appearance and participate in the case. Failure to appear will preclude you from contesting this matter at a later date. The attorney for Nadel and Gussman Permian, L.L.C. is James Bruce, P.O. Box 1056, Santa Fe, New Mexico 87504. The units are located approximately 6 miles east-northeast of Otis, New Mexico.
