1           WHEREUPON, the following proceedings were had at  
2   9:04 a.m.:

3           CHAIRMAN FESMIRE: Good morning. Let the record  
4 reflect that this is the March 16th, 2007, meeting of the  
5 New Mexico Oil Conservation Commission. Also let the  
6 record reflect that Commissioner Jami Bailey, the designee  
7 of the Land Commissioner, Mr. Patrick Lyons, Commissioner  
8 William Olson and Commissioner Mark Fesmire are all three  
9 present. We therefore have a quorum.

10           The first order of business before the Commission  
11 is the adoption of the minutes from the February 8th, 2007,  
12 Commission meeting. Have the Commissioners had a chance to  
13 examine the minutes?

14           COMMISSIONER BAILEY: Yes, I have, and I move we  
15 adopt them.

16           CHAIRMAN FESMIRE: Is there a second?

17           COMMISSIONER OLSON: Second.

18           CHAIRMAN FESMIRE: All those in favor?

19           COMMISSIONER BAILEY: Aye.

20           COMMISSIONER OLSON: Aye.

21           CHAIRMAN FESMIRE: Let the record reflect that  
22 the adoption of the minutes was unanimously approved by the  
23 Commission. The minutes will be signed and transmitted to  
24 the secretary.

1 CHAIRMAN FESMIRE: The next matter of business  
2 before the Commission is Case Number 13,274, a *de novo* case  
3 continued from the February 8th, 2007, Commission meeting.  
4 The case will be continued to the April 19th, 2007,  
5 Commission meeting. It's the Application of Pogo Producing  
6 Company as a successor to Arch, Inc., for approval of two  
7 nonstandard gas spacing and proration units in the Jalmat  
8 Gas Pool, Lea County, New Mexico.

9 The next case before the Commission is Case  
10 Number 13,531, the Application of Yates Petroleum  
11 Corporation for an order directing, first, Pride Energy to  
12 reimburse Yates for the well costs incurred by Yates in its  
13 attempt to re-enter the State "X" Well Number 1 located in  
14 Section 12, Township 12 South, Range 34 East, NMPM, prior  
15 to the time Pride Energy assumed operations of the well,  
16 and number two, directing Pride Energy to account for and  
17 pay all sums it is now improperly holding pursuant to the  
18 expired orders of the Division and the Commission, and  
19 three, requiring Pride Energy to plug and abandon the State  
20 "X" Well Number 1, Lea County, New Mexico. This case has  
21 been continued from the February 8th, 2007, Commission  
22 meeting, and will be continued to the April 19th, 2007,  
23 Commission meeting.

24 The next cause before the Commission is Case  
25 Number 13,695, the Application of Chaparral Energy, L.L.C.,

1 for approval of a saltwater disposal well in Lea County,  
2 New Mexico. This is a *de novo* continued from the February  
3 8th, 2007, Commission meeting, and the case will be  
4 continued to the May 17th, 2007, Commission meeting.

5 Also before the Commission today is Case Number  
6 13,817, the Application of Harvey E. Yates Company for an  
7 exemption from the Oil Conservation Commission Rule  
8 19.15.2.50.(A). Applicant has requested that the case be  
9 continued from the February 8th, 2007, Commission meeting  
10 and continued to the May 17th, 2007, Commission meeting.

11 Also before the Commission --

12 COMMISSIONER OLSON: Well --

13 CHAIRMAN FESMIRE: Commissioner?

14 COMMISSIONER OLSON: -- I guess we had a motion  
15 on that. Is that -- we just take that up at the next  
16 meeting, I guess?

17 CHAIRMAN FESMIRE: It was the Chair's intention  
18 to rule on that at the next Commission meeting.

19 COMMISSIONER OLSON: Okay.


