In accordance with the provisions of Division Order No. R-12514, as amended, entered on March 6, 2006, which order promulgated temporary special pool rules for the Sand Springs Permo Upper-Pennsylvanian Pool in Lea County, New Mexico, including provisions for 160-acre spacing units and designated well locations, the Oil Conservation Division is reopening Case No. 13629 in order that the operators in the Sand Springs Permo-Upper Pennsylvanian Pool may appear and show cause why the temporary special rules for the pool should not be rescinded and the pool not be developed on statewide 40-acre spacing.

This case will appear on the docket for the Examiner Hearing to be held on March 1, 2007. This hearing will be held in Porter Hall, 1220 S. St. Francis Drive, Santa Fe, New Mexico, at 8:15 a.m. A copy of the advertisement for the March 1, 2007 hearing is enclosed.

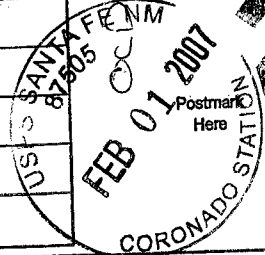
