NMPM, Eddy County, New Mexico, forming a standard 320-acre gas spacing and proration unit for production from any and all formations or pools developed on 320-acre spacing including but not limited to the Four Mile Draw-Morrow Gas Pool. This unit is to be dedicated to its Blue Cat Fee Well No. 1 (API# 30-015-34608) to be drilled at a standard gas well location in Unit G of this section.
