1 WHEREUPON, the following proceedings were had at
2 11:24 a.m.:

3 EXAMINER BROOKS: At this time we'll call Case
4 Number 13,777, the Application of Cimarex Energy Company
5 for a nonstandard oil spacing and proration unit and
6 compulsory pooling, Lea County, New Mexico. This again was
7 called to supplement the record.

8 MR. BRUCE: Mr. Examiner, Jim Bruce of Santa Fe,
9 representing the Applicant.

10 First submitted to you is Exhibit 6, which is the
11 notice affidavit. 105 interest owners were notified in
12 writing of this Application, a number of them unlocatable.

13 As a result, I had to republish it to get
14 everybody properly in the affidavit of publication in the
15 Carlsbad paper submitted as Exhibit 7, being the
16 unlocatable people.

17 And I only made one copy of this, but resubmitted
18 to you as Exhibit 2 is the listing of the interest owners.
19 And highlighted in green are the people who received actual
20 notice, as shown by the affidavit of publication. And the
21 ones -- it used to be orange, I think it turned pink over
22 the intervening time, are the people who did not receive
23 notice and who were notified by publication. And there are
24 probably a couple of names that aren't highlighted either
25 way. I think all of those were also notified by

1 publication. As of the making of this list I hadn't
2 received back all the green cards.

3 But that will help you when you're reviewing the
4 matter with respect to notice.

5 EXAMINER BROOKS: Very good, Exhibits 2, 6 and 7
6 will be admitted in evidence.

7 Anything further?

8 MR. BRUCE: No, sir.

9 EXAMINER BROOKS: Then Case Number 13,777 will be
10 taken under advisement.


