1 WHEREUPON, the following proceedings were had at
2 10:53 a.m.:

3 EXAMINER JONES: Okay, let's call Case 13,937,
4 continued from July 12th, Application of Mewbourne Oil
5 Company for compulsory pooling, Eddy County, New Mexico.
6 Call for appearances.

7 MR. BRUCE: Mr. Examiner, Jim Bruce of Santa Fe,
8 representing the Applicant. I am also submitting this case
9 by affidavit.

10 EXAMINER JONES: Okay.

11 MR. BRUCE: Mr. Examiner, in this case Mewbourne
12 Oil Company seeks to pool the south half of Section 3, 20
13 South, 29 East, solely for 320-acre units. Submitted is
14 the verified statement of Larry Cunningham who's a landman
15 at Mewbourne Oil Company.

16 The proposed location of the well is in the
17 northwest quarter southwest quarter of Section 3, and it
18 will test the Morrow formation.

19 Again, some fairly small interests are involved.
20 These people have all been contacted but have never
21 voluntarily joined in the well. There's about maybe .35
22 percent not tied up in the well. Mewbourne asks a 200-
23 percent risk charge against these people and overhead rates
24 of \$6500 and \$650 per month.

25 Exhibit A attached to Exhibit 1 is just simply a

1 land plat outlining the well unit.

2 Exhibit B are copies of the correspondence to
3 these parties, and -- with well proposals.

4 And Exhibit C is a copy of the AFE for the well.

5 Submitted as Exhibit 2 is my affidavit of notice.

6 You'll see on the notice, notice was also sent to Cimarex
7 Energy Company, but they have come to terms with Mewbourne
8 Oil Company and are not being pooled in this Application.
9 Notice was received by everyone.

10 We also had several different addresses for Mill
11 Neck Associates, but at least two of the three notices
12 we've sent to Mill Neck Associates were received, so there
13 is no affidavit of publication.

14 And we'd ask that this matter be taken under
15 advisement.

16 EXAMINER JONES: Thank you. With that, we'll
17 take Case Number 13,937 under advisement.

18 (Off the record)

19 EXAMINER JONES: Let's do a 15-minute break,
20 then. Let's come back at 11:15.
