At this time I'll ask the Commissioners if they 10 have had the opportunity to review the minutes as presented 11 by the secretary. 12 COMMISSIONER BAILEY: Yes, I have, and I move we 13 14 adopt them. 15 CHAIRMAN FESMIRE: Is there a second? 16 COMMISSIONER OLSON: Second. 17 CHAIRMAN FESMIRE: The minutes as presented by the secretary -- the motion has been made that they be 18 adopted and signed. 19 All those in favor? 20 21 COMMISSIONER BAILEY: Aye. 22 COMMISSIONER OLSON: Aye. 23 CHAIRMAN FESMIRE: Opposed? Let the record reflect that the minutes were 24 25 adopted unanimously by the Commission. They will be signed

and conveyed to the Secretary at this time.

CHAIRMAN FESMIRE: The meeting was called to order at nine o'clock by the Chairman. The Commissioners present were Commissioner Bailey, Commissioner Olson and Commissioner Fesmire. The Commission therefore has a quorum.

That case will be 7 CHAIRMAN FESMIRE: Okav. continued to the November 16th, 2006, Commission meeting. 8 9 10 The next is Case Number 11 CHAIRMAN FESMIRE: 12 It was continued from the August 31, 2006, Examiner Hearing. This case will be dismissed. It's the 13 14 Application of Lynx Petroleum Consultants, Inc., for an 15 adjudicatory hearing in Eddy County, New Mexico. 16 There are some motions pending on that case. Are these motions mooted by the actions of the parties? 17 18 MS.
