The next case before the Commission is Cause 1 2 Number 13,531, continued from the August 10th, 2006, 3 Commission meeting. This case is the Application of Yates 4 Petroleum Corporation for an order directing Pride Energy 5 to reimburse Yates for the well costs incurred by Yates in its attempt to re-enter the State "X" Well Number 1, 6 7 located in Section 12, Township 12 South, Range 34 East, 8 prior to the time that Pride Energy assumed operations of 9 the well and, (2) directing Pride Energy Company to account 10 for an pay all sums it is now improperly holding pursuant to expired orders of the Division and Commission, and (3) 11 requiring Pride Energy to plug and abandon the State "X" 12 Well Number 1 in Lea County, New Mexico. 13 14 The record will reflect that again this case will 15 be continued to the October 19th, 2006, regularly scheduled 16 meeting. 17 (Thereupon, these proceedings were concluded at 9:03 a.m.) 18 19 20 21 22 23 24
