Mr. Price and/or Mr. Chavez will address environmental and safety issues, including the following:

1. The need for information on brine caverns the vicinity of the Targa South Eunice Gas Plant near the proposed disposal well, including sonar testing.
2. The need for a major modification to the Eunice Middle Gas Plant Discharge Plan (GW-005), and the need for a minor modification to the Eunice South Compressor Station Discharge Plan (GW-344), which must include Rule 118 H2S contingency plans.

Mr. Williams will address issues related to the construction of the well, including surface casing.
