From what I can glean from some of the old well files in the Langlie Mattix Penrose Unit. Water sands exist from approximately 715 feet to approximately 850. In Section 2 – 23S- 37E about a mile southeast of the plant Santa Rosa water was encountered at approximately 900' by the State Engineers Office when drilling a test well last year. The surface casing should be set at least 50' into the Rustler Anhydrite at about 1150'. The production casing should be set through the San Andres and circulated to surface or at least 200' inside the surface casing.
