

APPLICATION

Samson Resources Company applies for an order pooling all mineral interests from the surface to the base of the Barnett Shale underlying the E½ of Section 32, Township 20 South, Range 36 East, N.M.P.M., Lea County, New Mexico, and in support thereof, states:

1. Applicant is an interest owner in the E½ of Section 32, and has the right to drill a well thereon.
2. Applicant proposes to drill its Osudo 32 State Com. Well No. 2, at an orthodox location in the NE¼NE¼ of Section 32, to a depth sufficient to test the Barnett Shale, and seeks to dedicate the E½ of Section 32 to the well to form a standard 320 acre gas spacing and proration unit for any formations and/or pools developed on 320 acre spacing within that vertical extent.
3. Applicant has in good faith sought to obtain the voluntary joinder of all other mineral interest owners in the E½ of Section 32 for the purposes set forth herein.
4. Although applicant attempted to obtain voluntary agreements from all mineral interest owners to participate in the drilling of the well or to otherwise commit their interests to the well, certain interest owners have failed or refused to join in dedicating their interests. Therefore, applicant seeks an order pooling all mineral interest owners in the E½ of Section 32, pursuant to NMSA 1978 §70-2-17.


5. The E½ of Section 32 will be simultaneously dedicated to the proposed well and the Osudo 32 State Com. Well No. 1, located in the SE¼ of Section 32.

6. The pooling of all mineral interests underlying the E½ of Section 32 will prevent the drilling of unnecessary wells, prevent waste, and protect correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the Division enter its order:

- A. Pooling all mineral interests in the E½ of Section 32, from the surface to the base of the Barnett Shale;
- B. Designating applicant as operator of the well;
- C. Considering the cost of drilling and completing the well, and allocating the cost among the well's working interest owners;
- D. Approving actual operating charges and costs charged for supervision, together with a provision adjusting the rates pursuant to the COPAS accounting procedure; and
- E. Setting a 200% charge for the risk involved in drilling and completing the well in the event a working interest owner elects not to participate in the well.

The unit is to be dedicated to the proposed Osudo 32 State Com. Well No. 2 to be drilled at an orthodox location in the NE/4NE/4 of Section 32. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well. The unit is located approximately 9 miles southwest of Monument, New Mexico.
