

APPLICATION

Read & Stevens, Inc. applies for an order limiting the well spacing rules of the Lea-Pennsylvanian Gas Pool (the "Pool") to its current horizontal extent, and in support thereof, states:

1. Applicant is a working interest owner in the Pool.
2. The Pool was created by Commission Order No. R-2101, dated November 1, 1961, and currently covers the following lands in Lea County, New Mexico:

Township 20 South, Range 34 East, N.M.P.M.

Section 2:	E½
Section 3:	S½
Section 4:	E½
Section 9:	E½
Sections 10-14:	All
Section 24:	All
Section 25:	N½

3. The Commission's statewide rules in effect upon the creation of the Pool provided for 160 acre spacing for Pennsylvanian gas pools. Those rules still apply to the Pool.
4. Applicant requests that the well spacing rules for the Pool be limited to acreage currently within the designated horizontal extent of the Pool, so that future development in the area outside of the above-described area is governed by the Division's statewide rules.
5. The granting of this application is in the interests of conservation, the prevention of waste, and the protection of correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the relief requested above be granted


