## **APPLICATION**

ENERGEN RESOURCES CORPORATION by its undersigned attorneys, Miller, Stratvert P.A., (J. Scott Hall) hereby makes application pursuant to NMSA 1978 Section 70-2-17 (1995) for an order pooling all interests in the Fruitland Coal formation, Basin-Fruitland Coal Gas Pool, underlying the W/2 of Section 13, Township 32 North, Range 6 West, NMPM, Rio Arriba County, New Mexico, to form a standard 320-acre spacing and proration unit. Applicant would show the Division:

- 1. Applicant owns certain working interests in and under the W/2 of Section 13 and has the right to drill thereon.
- 2. Applicant proposes to dedicate the above-referenced pooled unit to its Navajo Lake Well No. 103 drilled to a depth sufficient to test the Fruitland Coal Formation, Basin-Fruitland Coal Gas Pool, underlying the W/2 of Section 13. The well will be directionally drilled from a surface location 780 feet from the North line and 2,600 feet from the East line in adjoining Section 24, penetrating the Fruitland Coal formation at a point no closer than 660 feet from the South line and 1,980 feet from the West line in the SW/4 of Section 13, with a bottom hole location in Section 13 2,300 feet from the North line and 1,200 feet from the West line, all in Township 32 North, Range 6 West, NMPM, Rio Arriba County, New Mexico.

3. Applicant has been unable to obtain leases or voluntary agreement for pooling or

farmout from certain other interest owners in the above-referenced formations underlying the

W/2 of said Section 13.

4. In order to permit the Applicant to obtain its just and fair share of the oil and gas

underlying the subject lands, the mineral interests should be pooled and Applicant should be

designated operator of the well.

5. The pooling of interests well location will afford the Applicant the opportunity to

produce its just and equitable share of hydrocarbons underlying the spacing unit, will avoid the

drilling of unnecessary wells, will prevent waste and will protect correlative rights.

WHEREFORE Applicant requests that this Application be set for hearing before a duly

appointed examiner of the Oil Conservation Division on July 12, 2007 and that after notice and

hearing as required by law, the Division enter its Order approving the Application and pooling

the lands, including provisions for Applicant to recover its costs of drilling, equipping and

completing the well, its costs of supervision while drilling and after completion, including

overhead charges and providing for adjustments to such rates in accordance with accepted

COPAS accounting procedures, and imposing a 200% risk factor for the risk assumed by the

Applicant in drilling, completing and equipping the well, and making such other and further

provisions as maybe proper in the premises.

Applicant seeks an order pooling all mineral interests in the Fruitland Coal formation, (Basin-Fruitland Coal Gas Pool) underlying the W/2 of Section 13, Township 32 North, Range 6 West, NMPM, Rio Arriba County, New Mexico, forming a standard 320acre spacing and proration unit to be dedicated to the Navajo Lake Well No. 103. The well will be directionally drilled from surface location 780 feet from the North line and 2,600 feet from the East line of adjoining Section 24, penetrating the Fruitland Coal formation at a point no closer than 660 feet from the South line and 1,980 feet from the West line in the SW/4 of Section 13, with a bottom hole location in Section 13, 2,300 feet from the North line and 1,200 feet from the West line, all in Township 32 North, Range 6 West, NMPM, Rio Arriba County, New Mexico.
