**STATEMENT OF THE CASE**

**APPLICANT**

Applicant seeks an order amending order No. R-12702, which pooled all mineral interests from the surface to the base of the Morrow formation underlying the E/2 of Section 16, Township 23 South, Range 24 East, NMPM, to form a standard 320-acre gas spacing and proration unit for all pools or formations developed on 320-acre spacing within that vertical extent, including the Undesignated South Bandana Point-Strawn Gas Pool, Undesignated Robina Draw-Atoka Gas Pool, and Undesignated Bandana Point-Strawn Morrow Pool. The unit is dedicated to the Renata "16" State Well No. 1, to be drilled at an orthodox location in the NE/4NE/4 of Section 16. Order No. R-12702 stated the well's location as 660 feet from the north and east lines of Section 16, but due to topography the well's location has been moved to 660 feet from the north

line and 910 feet from the east line. Applicant requests that Order No. R-12702 be amended to reflect the correct location, and that all other provisions of the order remain the same.


