

APPLICATION

Harvey E. Yates Company applies for an order approving an expansion of the Bennett Ranch Unit Area, and in support thereof, states:

1. Applicant is a working interest owner in, and is the operator of, the Bennett Ranch Unit Area, an exploratory unit comprising 8,856.90 acres of federal and state lands in Otero County, New Mexico.

2. The unit area was approved by Division Order No. R-10,527, and the lands within the unit are described in Exhibit A attached hereto. The order requires Division approval to expand the unit area.

3. Applicant requests that the unit area be expanded to cover the lands described below:

A plat of the expanded unit area is attached as Exhibit B, indicating the expansion area.

4. The expansion of the unit area has been preliminarily approved by the United States Bureau of Land Management and the Commissioner of Public Lands.

5. The approval of this application will prevent waste and protect correlative rights.

WHEREFORE, applicant requests that, after hearing, the Division enter its order approving the relief requested herein.


