On October 15, 2007, the Bureau of Land Management advised this office that they concurred with your determination for the above-mentioned well.

The Commissioner of Public Lands concurs with ConocoPhillips and the Bureau of Land Management's determination that the San Juan 29-7 Unit Well No. 4C is not capable of producing unitized substances in paying quantities from the Dakota formation and should be produced on a lease basis.




