WHEREUPON, the following proceedings were had at 8:25 a.m.:

EXAMINER JONES: And let's call Case 13,908, which is the Application of OXY USA WTP, Limited

Partnership, for authorization to simultaneously dedicate a standard spacing and proration unit in the Wolfcamp formation to a horizontal well and two vertical wells, Eddy County, New Mexico.

Call for appearances.

MR. CARR: May it please the Examiner, my name is William F. Carr with the Santa Fe office of Holland and Hart. We represent OXY USA WTP, Limited Partnership, in this matter, and I have a statement.

EXAMINER JONES: Any other appearances?
Okay.

MR. CARR: Mr. Examiner, this case was originally heard by a Division Examiner on the 21st of June. At the end of the hearing the case was continued to allow OXY to identify affected persons in Section 16 of Township 20 South, Range 28 East, which immediately offset the subject spacing unit to the west, the reason being that if the ownership was different in that tract, in that offsetting spacing unit, then the working interest owners in that section, or the operator, would have to also be notified.

OXY has reviewed the title data. OXY is the

operator of the Wolfcamp formation in Section 16, and in 1 2 addition to that they are the only working interest owner in the Wolfcamp. COG owns some interests in shallower 3 horizons, but not in the Wolfcamp. And since OXY is the 4 operator and owns all working interest, we believe that the 5 notice originally provided covered everything and that no 6 further notice should be required, and we would request 7 that the case be taken under advisement. EXAMINER BROOKS: Yeah, that was a case that I 9 heard, and I believe that should take care of the 10 outstanding items, so Case Number 13,908 will be taken 11 12 under advisement.
