**SCHEDULING ORDER**

The Chair of the New Mexico Oil Conservation Commission (Commission) gives notice of the following:

1. On March 16, 2007, the Commission entered Order No. R-12343-E establishing a 640-acre spacing unit for Chesapeake Operating, Inc.'s (Chesapeake) KF "4" State Well No. 1 (KF-4) and designating Samson Resources Company (Samson) as operator of the well.

2. The Chairman granted Chesapeake's Application for a Rehearing by Order No. R-12343-F, dated April 11, 2007, "to take evidence and testimony on 1) why the Oil Conservation Commission should or should not uphold its establishment of a 640-acre proration unit in the southern two thirds of Section 4, Township 21 South, Range 35 East, NMPM, and 2) which entity should be the operator of the KF-4 Well and any future wells in the proration unit."

3. The matter was set for May 17, 2007 and continued until July 19, 2007 in Porter Hall, Wendell Chino Building, 1220 S. St. Francis Drive, Santa Fe, New Mexico. The hearing will begin at 9:00 a.m.

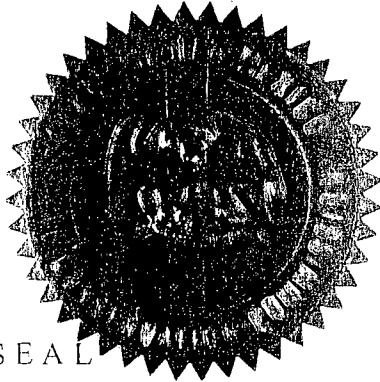
4. The parties shall file with the commission clerk prehearing statements, witness lists, and any replacement or new exhibits at least 10 business days prior to July 19, 2007, which is Thursday, July 5.

5. The parties shall file with the commission clerk any additional rebuttal exhibits and witnesses at least five business days prior to July 19, 2007, which is Thursday, July 12, 2007.

6. Three hours shall be allotted to Chesapeake for the presentation of testimony and evidence including rebuttal.

7. Samson Resources Company, Kaiser-Francis Oil Company and Mewbourne Oil Company shall be allotted three hours between them to present their testimony and evidence including rebuttal.
