As you requested, attached is supplemental notice information.

Attached as Exhibit A is a listing of the lands in the pool. I examined the Division's well records as to all acreage in the pool, and copies of that information is attached as Exhibit B.¹ The only parties notified of the hearing were M.E.W. Enterprises, Mercury Exploration Company, Pecos River Operating Inc., and Yates Petroleum Corporation. (The landman testified that Pecos River Operating Inc. has acquired the interests of Mercury Exploration Company.) A review of Exhibit B shows that these four companies (highlighted in yellow) are the only operators in the pool other than applicant. (In addition, there are no other operators within a mile of the pool boundaries.) Because no change in spacing is sought, these four companies are the only entities entitled to notice.
