#### STATEMENT OF THE CASE

#### **APPLICANT**

Applicant seeks an order pooling all mineral interests from the surface to the base of the Upper Pennsylvanian formation underlying Lots 6, 7, E/2SW/4, and SE/4 (the S/2) of Section 6, Township 25 South, Range 27 East, NMPM, to form a standard 316.80-acre gas spacing and proration unit for all pools or formations developed on 320-acre spacing within that vertical extent. The unit is to be dedicated to the Scoter 6 Fed. Com. Well No. 1, to be re-entered at a location 1650 feet from the south line and 1040 feet from the west line of Section 6. Also to be considered will be the cost of re-entering and completing the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of Cimarex Energy Co. of Colorado as operator of the well, and a 200% charge for the risk involved in re-entering and completing the well.
