STATEMENT OF THE CASE

APPLICANT

Applicant seeks an order pooling all mineral interests from the surface to the base of the Wolfcamp formation underlying the S/2 of Section 36, Township 15 South, Range 24 East, NMPM, to form a standard 320-acre gas spacing and proration unit for all formations developed on 320 acre spacing within that vertical extent, including the West Cottonwood Creek-Wolfcamp Gas Pool. The unit is to be dedicated to the proposed Old Rosebud 1524-36 A State Well No. 1, to be drilled at a surface location 760 feet from the south line and 200 feet from the east line of Section 36, with a penetration point 760 feet from the south line and 660 feet from the east line of Section 36 and a terminus 760 feet from the south line and 660 feet from the west line of Section 36. Also to be considered will be the cost of drilling and completing the well and the

allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling and completing the well.
