Cimarex Energy Co. seeks an order approving a non-standard oil spacing and proration unit (project area) comprised of the E/2NE/4 of Section 13, Township 15 South, Range 37 East, NMPM, to form a non-standard 80-acre oil spacing and proration unit (project area) for any and all formations or pools developed on 40-acre spacing within that vertical extent, including the Denton-Wolfcamp Pool, and pooling all mineral interests in the Wolfcamp formation underlying the non-standard unit. The unit is to be dedicated to the Sherman 13 Fee Well No. 3, a horizontal well to be drilled at a surface location 430 feet from the north line and 430 feet from the east line of Section 13, with a terminus 2310 feet from the north line and 430 feet from the east line of Section 13. Also to be considered will be the cost of drilling and completing the well and the
