## Gentlemen:

Mewbourne Oil Company ("Mewbourne") hereby proposes drilling an 11,600' Morrow at a location 1,980' FNL & 660' FWL of Section 28, T-20-S, R-36-E, Lea County, New Mexico to be called the Paloma "28" Fed COM #1 well. Assuming a successful completion requiring 320 acre spacing, a W/2 communitized proration unit would be established. Accordingly, Mewbourne also hereby proposed the formation of a 320 acre working interest unit covering the W/2 of said Section 28 for the drilling of the proposed well. Based upon our most current title information EOG Resources, Inc. ("EOG") appears to own 100% working interest in State of New Mexico Lease E-5164-3 insofar as it covers the SW/4 of said Section 28 limited to depths below 4,407'. Assuming our information is correct, EOG would have a 50.0% interest in a W/2 working interest unit below 4,407'.

Should EOG choose to participate in the proposed well, please so indicate by executing and returning one of the enclosed AFE well cost estimates. Upon receipt of your election to participate, an AAPL 1989 Model Form JOA will be forwarded for your review and approval. Should EOG choose not to participate, Mewbourne reaffirms its previous offer dated July 18, 2007 to purchase a two (2) year Term Assignment covering all of EOG's interest in the SW/4 of Section 28 and the NW/4 of said Section 33 for \$300.00 per net mineral acre based upon delivery of a 75% net revenue to Mewbourne and use of a mutually acceptable Term Assignment form.
