AMENDED APPLICATION

CHESAPEAKE OPERATING, INC., ("Chesapeake") through its undersigned attorneys, hereby makes application to the Oil Conservation Division pursuant to the provisions of NMSA 1978; § 70-2-17, for an order pooling all mineral interests from 4,000 feet to 15,751 feet (Ellenburger formation) in the following described spacing and proration units located in the N/2 of Section 21, Township 22 South, Range 36 East, N.M.P.M., Lea County, New Mexico: Section 21 for all formations and/or pools developed on 640-acre spacing which includes but is not limited to the Jalmat-Tansill-Yates-Seven Rivers Gas Pool; the N/2 for all formations and/or pools developed on 320-acre spacing which includes but is not limited to the Langley-Devonian Gas Pool and the Langley-Ellenburger Gas Pool; and the W/2 NW/4 for all formations and/or pools developed on 40-acre spacing which includes but is not limited to the South Eunice-Seven Rivers-Queen Pool, the Langely-Strawn Pool or the Undesignated Southwest Arrowhead-Grayburg Pool. In support of its application, Chesapeake states:

1. Chesapeake is a working interest owner in the N/2 of said Section 21 and has the right to drill thereon.

2. Chesapeake proposes to dedicate the above-referenced spacing or proration units to its Langley Greer Well No. 3H. This well is located in Section 21, Township 22 South, Range 36 East, N.M.P.M., and will be drilled to test the Devonian formation, Langley-Devonian

Gas Pool, from an unorthodox surface location 2440 feet from the South line and 660 feet from the West line, intersecting the Devonian formation at an unorthodox penetration point 2310 feet from the North and West line, and to a standard bottomhole location 660 feet from the North and West lines of said Section 21, Lea County, New Mexico.

3. Chesapeake has sought and been unable to locate and obtain a voluntary agreement for the development of these lands from certain interest owners in the subject spacing units. These owners are identified on **Exhibit A** to this application.

4. Said pooling of interests will avoid the drilling of unnecessary wells, will prevent waste and will protect correlative rights.

5. In order to permit Chesapeake to obtain its just and fair share of the oil and gas underlying the subject lands, all mineral interests should be pooled, and Chesapeake should be designated the operator of the well to be drilled.

WHEREFORE, Chesapeake Operating, Inc. requests that this application be set for hearing before an Examiner of the Oil Conservation Division on January 10, 2008 and, after notice and hearing as required by law, the Division enter its order:

A. pooling all mineral interests in the subject spacing and proration units;

- B. designating Chesapeake Operating, Inc. operator of these units and the well to be drilled thereon;
- C. authorizing Chesapeake Operating, Inc. to recover its costs of drilling, equipping and completing the well;
- approving the actual operating charges and costs of supervision while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and

E. imposing a penalty for the risk assumed by Chesapeake Operating, Inc. in drilling and completing the well against any working interest owner who does not voluntarily participate in the drilling of the well.
