AS GROUNDS Applicant Oil Conservation Division states:

- (1) The case is scheduled for hearing on November 1, 2007, at 8:15 a.
- (2) On October 17, 2007, Rob Matthews, owner of Rojo Grande Company, LLC (hereinafter, "Operator"), left a message on undersigned counsel's voice mail stating he had just returned the Ramapo No. 006 well to production.
- (3) On October 18, 2007, an OCD inspector inspected the well to determine if it was indeed active. The inspector found a note on the electric meter box dated October 10, 2007, informing Operator that it needed to contact the electric company to have the meter connected.

- (4) On October 26, 2007, undersigned counsel spoke with Mr. Matthews about whether the well was indeed active. Mr. Matthews said the well was recently connected to electricity from a different location and that water was coming from the well when they started pumping. Mr. Matthews expects oil to be coming from the well soon. Mr. Matthews said he would be filing production reports soon.
- (5) Mr. Matthews did not object when I told him that I would be continuing to case to determine if the well is indeed active.
- (6) Undersigned Counsel is trying to determine if the well is indeed active.

WHEREFORE, Undersigned Counsel requests that the hearing for November 1, 2007 be continued to January 10, 2008 hearing calendar.
