A hearing has been scheduled on the above application for Thursday, January 10, 2008, at 8:15 a.m. in Porter Hall, First Floor, at 1220 South St. Francis Drive, Santa Fe, New Mexico.

In October you called me on the telephone to tell me that the Ramapo No. 006 had been returned to production. However, as of this date, the well still appears on the inactive well list. If the well has been returned to production, C-115 monthly production reports have to be filed in order to remove the well from the inactive well list. The hearing will proceed unless and until C-115 reports have been filed with the Oil Conservation Division.
