To Whom It May Concern:

Bold Energy LP respectfully filed for administrative approval for a C-108 application for a Salt Water Disposal well, on its Antelope Ridge Unit No. 6 well for the purpose of disposing produced fluids in the non-commercial Delaware interval. This work would allow Bold Energy LP to supplement the disposal for the Antelope Ridge Unit and dispose of produced water that is anticipated from work to be performed on wells within the unit. The installation of the proposed disposal well will lower the current economic limit on each well and ultimately allow Bold Energy LP to recover additional reserves that would otherwise be left in place.

Please note that a Letter of Protest was forwarded to the New Mexico Oil Conversation District by surface owner, Bert Madera. After negotiations were agreed upon and Bold was in the process of taking action to fulfill their obligations, however, Mr. Madera has not followed through with his retraction letter as agreed as well as requesting additional considerations in which was not in the original agreement for the retraction of the Letter of Protest.

Bold Energy LP, 415 W. Wall, Suite 500, Midland, Texas 79701, (Contact: Shannon Klier 432-686-1100) has filed application with the Oil Conservation Division, Energy, Minerals and Natural Resources Department, State of New Mexico, for Administrative Approval and authority to inject salt water into the Antelope Ridge Unit No. 6 well located 1980' FNL and 1980' FEL of Section 3, Township 24 South, Range 34 East, Lea County, New Mexico.

The purpose of the water injection well is to dispose of salt water produced from the Antelope Ridge Atoka field as currently designated by the Oil Conservation Division.

Water to be disposed will be injected into the Delaware formation at an interval between 5,227 feet and 6,290' from surface.

The minimum injection rate is expected to be 500 barrels of water per day. The maximum injection rate is expected to be 2000 barrels of water per day.

The minimum injection pressure is expected to be 100 psi. The maximum injection pressure is expected to be 1034 psi.

This letter is to officially object to the above referenced application as submitted by Gray Surface Specialties on behalf of Bold Energy, L.P. Reasons for objection are as follows:

Application is dated 8/21/07 with cover letter dated 8/23/07. Information was sent to us Certified Mail/Return Receipt and was received and signed for this date (9/4/07). As stated in the cover letter, we have 15 days from the date the Application to object to same. **We were not given sufficient notice of this application.** We feel we should have been given the full 15 days notice (rather than the 3 days we were given) to determine our rights as well as our approval or disapproval of this Application.

We are concerned about noise pollution as we continue to deal with unsatisfactory noise levels coming from a plant owned by the applicant (Bold Energy, L.P.) despite assurances given to us by Bold that the noise would be reduced to a level acceptable to us.

No attachments were provided with the Application showing the location of the well as well as referenced chemical analysis of fresh water from our water well/fresh water station. Since this well provides the livelihood for most of the entire ranch, we are most concerned with the safety of this water well. There are no attachments which show geologic data as referenced in the Application which would include geologic name, depth of underground drinking water sources, etc.

There has been no discussion with me regarding necessary pipelines across my private lands, which I assume will be necessary if this Application is approved.
