STATEMENT OF THE CASE

APPLICANT

Applicant seeks an order approving a non-standard oil spacing and proration unit (project area) comprised of the N½N½ of Section 3, Township 26 South, Range 33 East, NMPM, to form a non-standard 160-acre oil spacing and proration unit (project area) for any and all formations or pools developed on 40-acre spacing within that vertical extent, and pooling all mineral interests in the Bone Spring formation underlying the non-standard unit. The unit is to be dedicated to the Red Bull 3 Fed. Com. Well No. 1H, a horizontal well to be drilled at a surface location 330 feet from the north line and 330 feet from the east line of Section 3, with a terminus 990 feet from the north line and 330 feet from the west line of Section 3. Also to be considered will be the cost of drilling and completing the well and the allocation of the cost thereof, as well as actual operating

costs and charges for supervision, designation of RSC Resources, L.P. as operator of the well, and a 200% charge for the risk involved in drilling and completing the well.
