Dear Working Interest Owner:

Chesapeake Exploration, L.L.C., (Chesapeake) is the operator of a majority of the active leases in the Quail Field in Lea County, New Mexico. As an experienced waterflood operator, currently operating 11 waterflood units in five states, including four in New Mexico, Chesapeake is proposing the formation of the Quail Queen Unit for implementing a secondary recovery project, with Chesapeake as operator.

Acreage in which you have a working interest is located within the proposed unit boundary. The Unit Agreement and Unit Operating Agreement are enclosed for your perusal and notification. Exhibit A of the Unit Agreement reflects a map, outlining the unit boundary, along with the proposed tracts. Exhibit B, identifies your working interest in each tract. Exhibit C lists the tract participations. Exhibit D of the Unit Operating Agreement lists your interest in the proposed unit. All interests are subject to title verification.

It is Chesapeake's proposal to waterflood the Queen "B" & "C" Formation the proposed unitized interval being 5,033' - 5,394'.

Chesapeake anticipates the unit to perform similarly to nearby analogous waterfloods in the area with a secondary-to-primary ratio of .9 to 1. Should performance prove that expectation reasonable, the proposed unit may produce an additional seven hundred thousand (700,000) barrels of secondary oil.

Total development costs required to complete secondary operations are estimated to be \$5,000,000.

A successful waterflood injection program requires the cooperation and approval of the various working interest owners. We urge you to review the enclosed information and, if you have any questions concerning the implementation and development of this unit, contact Greg Adams, Senior Reservoir Engineer, in Oklahoma City, (405) 767-4398.

Chesapeake has put together an aggressive schedule for unitization. Plans are to make Application to the New Mexico Oil Conservation Division in September, 2007 with a hearing set for October, 2007 asking for a unit effective date of December 1, 2007. Please sign and return the extra pages of the following in the self-addressed envelope as soon as possible.

This office has reviewed the unexecuted copy of unit agreement, which you have submitted on behalf of Chesapeake Exploration, for the proposed Quail Queen Unit, Lea County, New Mexico. This agreement meets the general requirements of the Commissioner of Public Lands and has this date granted you preliminary approval as to form and content.
