If OPERATOR does not so properly plug and abandon said wells, upon order of the DIVISION after notice and hearing, the total sum of this bond shall be forfeited to the DIVISION, as provided in NMSA 1978 Section 70-2-14.B, as amended. If the principal sum of this bond is less than the actual cost incurred by the DIVISION in plugging and abandoning said wells in accordance with Rules 101 and 202 and any other applicable rules or orders, OPERATOR, its successors, heirs or personal representatives, shall be liable under the provisions of NMSA 1978, Sections 70-2-14 or 70-2-38 as amended (as applicable), for such deficiency, and the DIVISION may initiate action, as provided in said statutes, to recover same.
