This office must approve the remediation plan for this and **all** spills prior to the actual remediation. In order to do this, we must know the extent of the contamination, both horizontally and vertically. This is done through sampling and the results of this sampling must be sent to OCD prior to the actual remediation.

All this information and procedures are contained in the Guidelines for Releases and Spills, which is located on our web page at the address listed in page two of the first attachment.
