NOMENCLATURE ADVERTISEMENT FOR HEARING OCTOBER 9, 2003

In the matter of the application of the Oil Conservation Division of the Energy, Minerals and Natural Resources Department upon it's own motion for an order for the creation, and extensions of certain pools in Chaves, Lea and Roosevelt Counties, New Mexico, and giving notice to all persons and parties interested in the subject matter thereof to show cause why such creations, contractions and extensions should not be made.
