1 MR. EZEANYIM: Well, then, we go to the supplementary
2 case page and call Case No. 13751. This is the Application of
3 Energen Resources Corporation in the Matter of Case No. 13751
4 Being Reopened Pursuant to Provisions of Division Order
5 No. R-12637.

6 Call for appearances.

7 MR. HALL: Mr. Examiner, Scott Hall from Montgomery &
8 Andrews on behalf of Energen Resources Corporation. I have no
9 witnesses this morning, just a brief statement.

10 MR. EZEANYIM: Any other appearances? Okay, you may
11 continue.

12 MR. HALL: Mr. Examiner, in 2006, by Order No. 12637,
13 the Division established 80-acre pool rules for the North
14 Burtner-Devonian Pool in Lea County. The special pool rules
15 were, of course, temporary and provided that the operator of
16 the pool appear back before the Division after a year's time to
17 report on the advisability of maintaining special pool rules
18 and 80-acre spacing.

19 After a year and some, actually, Energen has
20 determined that maintenance of spacing and development on 80
21 acres is no longer justified and recommends to the Division
22 that spacing revert back to statewide spacing at 40 acres. The
23 entirety of the pool is the north half of Section 3 in Township
24 5 South, Range 33 East. Energen owns and controls 100 percent
25 of the spacing units in the pool, and by reverting back to .

1 40-acre spacing, no interest owner or royalty owner's
2 participation in any well is diminished.

3 That's all I have.

4 MR. EZEANYIM: Thank you, Mr. Hall. Any questions?

5 MR. BROOKS: See, I talked to you about this case,
6 and I did not read the order. What I said to you -- I was
7 assuming, and I don't have the order in front of me so I'm
8 still assuming -- that it says that the special pool rules will
9 terminate unless they're extended; is that correct?

10 MR. HALL: That's correct. It's automatic.

11 MR. BROOKS: And that was the basis of my advice to
12 the Examiner, that we did not need any proof of -- we did not
13 need you to present any evidence at this hearing.

14 MR. EZEANYIM: Anything else?

15 MR. WARNELL: No.

16 MR. HALL: Is that it?

17 MR. EZEANYIM: That's it. At this point, Case
18 No. 13751 will be taken under advisement.


