In accordance with the provisions of Division Order No. R-12637 entered on September 19, 2006, which order promulgated temporary special pool rules for the North Burtner-Devonian Pool in Lea County, New Mexico, including provisions for 80-acre spacing units and designated well locations, the Oil Conservation Division is reopening Case No. 13751 in order that the operators in the North Burtner-Devonian Pool may appear and show cause why the temporary special rules for the pool should not be rescinded and the pool not be developed on statewide 40-acre spacing.
