- (ii) Pre-approving down-hole commingling of the Basin Mancos Gas Pool (97232), and
- (iii) Creating special pool rules for the Basin Mancos Gas Pool (97232).

Case 14133 Pre-hearing Statement Page 1 of 2 The creation of the Basin Mancos Gas Pool (97232) in San Juan, Rio Arriba and Sandoval Counties in New Mexico will allow a small resource to be developed in conjunction with Basin Dakota Gas Pool and Blanco Mesaverde Gas Pool wells. Providing for pre-approval for down-hole commingling with the Basin Dakota and Blanco Mesaverde gas pool wells pursuant to Rule 303.C.3.b will further serve to facilitate the development of the Basin Mancos Gas Pool. These requests being made by the Division through this Application are in the best interest of conservation, the prevention of waste and the protection of correlative rights

In addition, due to the unique character and positioning of the Basin Mancos, Gas Pool, the Division is requesting that special pool rules regarding spacing and setbacks (as specifically articulated in the First Amended Application) be created in association with this Pool to ensure that development and production of this pool is conducted in an orderly, efficient and environmentally sound manner.
