Dear OCD staff,

Having attended the a portion of the hearing concerning Rio Arriba County and the issue of drilling by Approach Operating, I would like to register my public comment by e-mail. I believe there are two main legal/regulatory issues at stake, of equal importance. First, Rio Arriba County is asserting its power to regulate drilling regardless of oversight by the OCD. If recent discussions in which OCD participated concerning the same issue in Santa Fe County are accurate, Rio Arriba does indeed have the power to do so. I strongly support its assertion of this right.

Second, based on testimony I heard from landowners, there is the issue of whether Approach fulfilled its legal and ethical obligations to surface owners. It appears that evasion, secrecy, and lack of honesty or clarity has characterized the interaction of Approach with local property owners. For this reason, the County has the authority to pull drilling permits and to deny those pending.

Finally, I want to comment on a larger environmental issue. The Tierra Amarilla is a rich, irreplaceable, and unique ecosystem within New Mexico, generating a huge amount of the state's surface water and containing very fragile intermontane and alpine environments. The use of invasive extractive technologies to strip vegetation, alter water flows, create changes in the level of air quality, create roads and drill pads that accelerate erosion, and irreversibly change the visual and auditory setting is not ethically acceptable. The natural resources of New Mexico are the first priority citizens and state agencies have, and this should guide any decision to allow use of a technology that is already on its way out as a viable source of energy for the state and the world.

Thank you for providing a forum for public comment on these extremely important proceedings.
