- 2. Applicant proposes to drill each of the Subject Wells to a depth sufficient to test the Mancos formation.
- The Oil Conservation Division has jurisdiction over the drilling and operation of oil and gas wells in this state, including the Subject Wells, pursuant to the New Mexico Oil and Gas Act, NMSA 1978 §§70-2-1, et seq., and the regulations administered by the Division found at 19.15.1.1 NMAC, et seq. The Division has accordingly directed Applicant to obtain approval of its APD's by way of examiner hearing.
- 4. Applicant owns or controls the leasehold operating rights in the lands described above and otherwise has the right to drill each of the Subject Wells. Under the terms of the lease, Applicant must drill eight wells before April 2, 2009. If it is prevented from drilling the wells, the lease is subject to automatic termination.
- 5. Applicant requests that the APD's for the Subject Wells be approved on a timely basis so that the termination of the lease may be avoided.
