In accordance with Section 10 of the Poker Lake Unit Agreement dated March 18, 1952, BEPCO, L.P., Operator of the referenced unit, hereby submits a Plan of Development for the Poker Lake Unit for the year 2008.

HISTORY OF PAST DEVELOPMENT

We refer to our previous Plans of Development for a detailed description of the operations conducted in this Unit in prior years.

2007 ACTIVITY

<u>Poker Lake Unit Well No. 168, Eddy County, New Mexico</u> – This well was drilled at a location being 1,730' FSL & 660' FWL, Section 5, T24S-R30E, Eddy County, New Mexico. This well was completed in the Delaware Formation as an oil well.

<u>Poker Lake Unit Well No. 201, Eddy County, New Mexico</u> – This well was drilled at a location being 2,139' FSL & 2,100' FWL, Section 7, T24S-R30E, Eddy County, New Mexico. This well was completed in the Delaware Formation as an oil well.

<u>Poker Lake Unit Well No. 279, Eddy County, New Mexico</u> – This well was drilled at a location being 1,650' FSL & 2,310' FWL, Section 19, Eddy County, New Mexico. This well was completed in the Delaware Formation as an oil well.

<u>Poker Lake Unit Well No. 289, Eddy County, New Mexico</u> – This well was drilled at a location being 800' FSL & 2,280' FWL, Section 18, T24S-R30E, Eddy County, New Mexico. This well was completed in the Delaware Formation as an oil well.

2007 PLUGGED AND ABANDONED

<u>Poker Lake Unit Well No. 91, Eddy County, New Mexico</u> - This well was plugged and abandoned at a location being 360' FNL, 330' FWL, Section 12, T25S-R30E, Eddy County, New Mexico. This well was plugged and abandoned June 13, 2007.

PARTICIPATING AREAS

The above Delaware wells are included in the proposed Fourth Revision to the Delaware C Participating Area which has been approved by the BLM and other agencies.

Bass has submitted Commercial Determinations for all productive wells for which same have not been prepared in the past and will submit wells drilled to date where adequate information is available for commercial determination and participating areas. In the event you have not received commercial determination for the wells that have been drilled and completed and are currently producing, please advise at your convenience and we will submit same to you.

FUTURE DEVELOPMENT

<u>Poker Lake Unit Well No. 162, Eddy County, New Mexico</u> – This well will be drilled at a legal location being 660' FSL & 1,980" FWL, Section 6, T24S-R30E, Eddy County, New Mexico to a proposed depth of 7,550' to test the Delaware Formation.

<u>Poker Lake Unit Well No. 183, Eddy County, New Mexico</u> – This well will be drilled at a legal location being 330' FNL & 1,980' FWL, Section 7, T24S-R30E, Eddy County, New Mexico to a proposed depth of 7,400' to test the Delaware Formation.

<u>Poker Lake Unit Well No. 220, Eddy County, New Mexico</u> – This well will be drilled at a legal location being 1,780' FSL & 990' FWL, Section 19, T24S-R30E, Eddy County, New Mexico to a proposed depth of 7,500' to test the Lower Delaware Formation.
